



## Team Hammer Track Ride Registration Instructions

Payment must be received with registration. Enclose payment in the form of a cashier's check, money order or credit card authorization for \$225 tuition with your registration forms. Registration applications received without payment will not be processed. **Personal checks are not accepted and will be returned.**

If you have attended a Team Hammer Advanced Riding School or Track Ride event and wish to attend again, you are eligible for a repeat discount rate of \$175. Enclose payment in the form of a cashier's check, money order or credit card authorization for \$175 with your registration forms. **Personal checks are not accepted and will be returned.**

Completed registration forms with payment must be received ten days prior to the date of the event. **Do not fax your registration.** Facsimile copies are not acceptable and your registration will not be processed. We need the original, signed paperwork with payment to process your registration.

EMAIL CONFIRMATION: Once your registration has been processed, you will receive a letter of confirmation via email. Be sure that your email address is accurate and clearly written. Print out your confirmation email and bring it with you to the track.

**At-Track Registration:** If you have missed the ten-day pre-registration deadline, you may still be able to attend the event depending on space availability. You must call the Team Hammer office at 951-245-6414 to check on availability before showing up at the track. We cannot guarantee a space at the event for walk-up registration.

A post-entry fee of \$50 will be added to the cost of tuition. Cash, money order or cashier's check, or credit card in the amount of \$275 will be accepted at the track. **No personal checks.**

Pre-registration is strongly recommended to avoid long lines and delays at the track. **DONT' MISS OUT - MAKE SURE YOU REGISTER BEFORE THE DEADLINE!**



## Restrictions and Requirements: Track Ride

### TRACK RIDE PRE-REQUISITES

- In order to participate in the Team Hammer Track Ride, you must have attended an approved riding school with classroom and on-track instruction. You must have prior racetrack experience, be familiar with racetrack rules and protocol, and be able to ride independently without instructors.

### REGISTRATION

- You must be at least 18 years old and you must be able to prove your age by showing us a valid driver's license with your photo on it or a valid passport. You will be required to show us your proof of age when you sign in at the track. Riders without valid photo I.D. will not be allowed to register.
- You must complete all required forms and sign all required liability releases, and pre-register with payment. We must receive your original signed paperwork at least 10 days before the event you wish to attend. We require the *original* forms to be mailed in; facsimiles are not acceptable.
- Late registration: If space is available, at-track registration will be accepted with an additional \$50 fee. Certain events fill up prior to the 10-day deadline, so in order to guarantee your space, pre-registration is strongly recommended. If the event is full, you will be turned away at registration, so be sure to call ahead to make sure that space is available.

### MOTORCYCLE PREPARATION

- You must use your own motorcycle; we do not provide rentals. Your motorcycle must pass tech inspection before you will be allowed on the racetrack.
- Your bike must be in good functional condition with safe tire tread depth and good working brakes. All glass and plastic lenses must be either removed or Team Hammer tech mechanics will tape them over with duct tape. Rearview mirrors must be removed; if you don't know how to do this, Team Hammer tech mechanics will do it for you at the racetrack.

### RIDING GEAR

- You must supply and wear your own good-condition, one-piece leather riding suit, full-face helmet, leather gloves and leather riding boots at least 8-inches in height. Two-piece leather suits that zip together at the waist are allowed only if the zipper extends around the entire circumference of the waist; two-piece suits that only zip together at the rear of the waist are not allowed. A limited number of leather suits are available for rental (boots and gloves are not available); call for information.

### FOOD & SUPPLIES

- You must bring your own food and water with you. Riding in a leather suit around a racetrack is very strenuous, especially on hot days. Bring at least one gallon of cold water or sports drink per person and make sure you drink enough to replace fluids lost by sweating, respiration, etc. If you feel too hot, rest in shade and drink cold water or sports drinks. You must also bring gas for your bike. Race gas is available for purchase at most racetracks for about \$6.50 a gallon and up.

### RULES

- You must agree to follow all School and Track Ride rules and instructions at all times during the track day. Reckless riding will result in loss of track privileges for the day without refund. Any crash ends the rider's track privileges without refund. No drugs or alcohol are allowed on the racetrack premises during the School or Track Ride day. All scheduled track time is subject to change due to emergency or track conditions. No rain checks.



## **About the Advanced Riding School, the Track Ride, and Practice**

Team Hammer has three events on the same day, each having different sessions on the racetrack throughout the day: The Advanced Riding School, the Track Ride, and Practice.

As a student in the Team Hammer Advanced Riding School, you have access to instructors, and there is both classroom and on-track time. Both racers and non-racers take the class, and the level is from beginning to advanced.

The Track Ride is for riders with track experience who want to ride around independently. There is no instruction or classroom time for the Track Ride. The Track Ride is not for racers who are participating in the weekend's race activities.

The Team Hammer Pro Practice is open to racers who are racing that weekend. The Practices are usually divided into three groups, each with their own session.

### **GATE PASSES**

The Track Ride fee includes one 3-day Event General Admission ticket with paddock access. Racetrack gate passes may be purchased at the registration building at the time of sign-in for non-participants accompanying riders.

### **LEATHER SUIT RENTAL**

Limited number of leathers will be available for rental (boots and gloves not available). Rental leathers must be reserved in advance.

### **WHAT TO DO WHEN YOU ARRIVE AT THE RACETRACK**

- Go to Team Hammer registration, outside the racetrack gate. Show driver's license or other picture ID and sign necessary forms as instructed. Pick up tech inspection form.
- Take your bike and tech inspection form to the Team Hammer tech inspection area.
- Follow staff instructions.
- Watch schedule for your session and listen for rarer announcements.
- Have fun!

## Release And Hold Harmless Agreement, Form C

The undersigned \_\_\_\_\_, desires to ride and participate in the "Team Hammer Advanced Riding School," or "Team Hammer Track Ride" or "Team Hammer Practice" conducted by Team Hammer, Inc. on **Daytona International Speedway** paved road racing course on **October 18, 2012**. The undersigned desires to do so all the while understanding and acknowledging that the sport of motorcycle riding and specifically riding in the above named School or Track Ride or Practice on the above named paved road course, is extremely dangerous and poses a great risk to life and limb.

With this understanding, for himself, his personal representatives, his heirs and next of kin, the undersigned:

1. **HEREBY RELEASES AND DISCHARGES FOR ALL TIME** Team Hammer, Inc., their retailers, their affiliates, subsidiaries, agents, employees, instructors, riders, mechanics, servants, sponsors, suppliers, officers, and directors, from all liability to the undersigned or anyone representing the undersigned for any loss or damages, on account of injury or damage or losses sustained by the undersigned, including his death, as a result of riding and/or participating in the above named School or Track Ride or Practice, whether caused by the negligence of Team Hammer, Inc., and whether on or off the racing premises, while the undersigned is participating in any School or Track Ride or Practice events or preparing to participate in any School or Track Ride or Practice events.

2. **HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE** while participating in any School or Track Ride or Practice events.

3. **HEREBY WAIVES ANY CLAIMS AND DOES COVENANT NOT TO SUE TEAM HAMMER, INC.**, John Ulrich, Trudy Ulrich, M4 or American Suzuki Motor Corp. for any claim which he may now have or may acquire against said entities or against any of their agents, representatives, or employees by reason of any injury or damages or loss sustained by him, including his death, as a result of participating in any School or Track Ride or Practice events whether on or off racetrack premises, regardless of the cause thereof.

4. **HEREBY AGREES THAT THIS RELEASE AND HOLD HARMLESS AGREEMENT** is intended to be as broad and inclusive as is permitted by the law of the state in which any of its activities are located, and if any portion of it is determined by a court of law to be invalid, the balance shall continue in full force and effect.

5. **HEREBY UNDERSTANDS** that Section 1542 of the California Civil Code provides that a general release does not extend to claims which the undersigned does not know or suspect to exist in his favor at the time of signing the release, which if he knew or suspected such claims, would have materially affected his willingness to sign the release.

6. **HEREBY WAIVES HIS RIGHTS** under Section 1542 of the Civil Code of California and any similar law of any other state, and acknowledges that this waiver is an essential term of this release without which he would not have signed this release. **THE UNDERSIGNED REPRESENTS THAT HE HAS READ, UNDERSTANDS AND IS VOLUNTARILY SIGNING THE RELEASE AND HOLD HARMLESS AGREEMENT**, and further represents that no verbal statements have been made to the undersigned to induce him to sign this Agreement.

## Rules Compliance Agreement, Form D

I further acknowledge and agree that School or Track Ride or Practice sessions are held rain or shine.** I acknowledge and agree that at-track scheduling is subject to delay and/or change due to factors beyond the control of Team Hammer, and that in case of reduced track time, regardless of cause, there will be no refunds or credits issued that tuition, track ride fees, and leather rental refund requests must be received in writing by Team Hammer, Inc. at least 10 days in advance of the School or Track Ride or Practice session, with no refunds made after that date.

I understand that compliance with School or Track Ride or Practice rules and the instructions and orders of School or Track Ride or Practice staff members is essential because riding a motorcycle on a racetrack is very serious and very dangerous. I understand that failure to comply with School or Track Ride rules and the instructions and orders of School or Track Ride or Practice staff members could increase the risk of serious injury or death to myself and other students and thus will not be allowed.

## Acknowledgement of Personal Injury Potential And Insurance Coverage Limits, Form F

I understand that in the event I do not have primary medical insurance coverage, I am responsible for the deductible and 20 percent of medical bills up to \$5000, as well as 100 percent of medical bills over \$5000 and any ambulance ride charges.

## Leathers Rental Agreement, Form G

1. I understand and acknowledge that no set of leathers can protect against all injury and that Team Hammer, Inc. makes no warranty express or implied regarding the protective abilities of rented leathers.

2. I understand and acknowledge that I am responsible for any damage caused to the rented leathers while they are in my possession. I agree to post a \$300 crash damage deposit to be applied to any necessary repairs made to return the rented leathers to acceptable condition, as determined by Team Hammer. In the event the rented leathers are damaged, the \$300 will be applied toward repairs and any unused portion of the \$300 will be returned to me by Team Hammer. In the event necessary repairs exceed \$300, I agree to pay Team Hammer the balance.

3. I agree to surrender my driver's license when I pick up the leathers and understand that my driver's license will be returned to me when I return the leathers.

4. In the event the leathers are lost or stolen while they are in my possession, I agree to pay Team Hammer the replacement cost as determined by Team Hammer.
